- Drive "ZERO DEFECT" mentality within supply base
- Drive customer feedback/complaint/return for root cause and corrective /preventive actions related to supply base
- · Recommend technical solutions for supplier improvements
- · Monitor and drive supplier PPM and initiate 8D for trending defects fallout detected at Production
- · Monitor and drive IQA PPM performance and ensure meeting the goals
- · Review and approve IQA inspection plan and ensure its compliance
- · Review and manage FAI to verify and ensure parts conformance to customer requirements
